

At the International Convention, new global service areas were announced to make it 5 areas of focus: hunger, vision, the environment, pediatric cancer and diabetes. The Centennial Challenge is going for one more year and if you read the Centennial report in this newsletter you can see what we have done for the past 3 years. As you are aware the Lions Magazine is now digital and there is an

app that can be downloaded for apple and android, you can search for the Lion Magazine to download. Also at convention was the release of the My Lion app. It can be found by searching MyLion by Lions Clubs International. This app is to make it easy to connect with other Lions Clubs members, set up and promote club service activities and discover more projects that interest you all from your mobile devices.

For District news, I attended the MD Council Meeting on July 21st, the meeting was well attended by both districts and business was completed in record time. I will be having my first cabinet meeting in August, date to be determined. I will be meeting with the District Executive to plan a budget to present at the meeting. We are into the final year of the International Centennial Celebration. I would like to provide you with updates as to what happened over the last 3 years. 2014-2015 as a district we served 39,972 people in our community with 22% of clubs reporting their activities. 2015-2016 we served 82,087 people in our community with 22% of clubs reporting their activities. This past year we served 105,352 people in our community with 35% of clubs reporting their activities. Just think if we had 100% of clubs reporting their activities where we would be at.

6. DISTRICT C-1 CITIZEN OF DISTINCTION

Purpose

To bring recognition to a deserving citizen living within the boundaries of Lions District C-1. The program will also raise the profile of Lions Clubs International.

Who will be recognized?

The Lions District C-1 Citizen of Distinction will be selected from those persons who demonstrate a personal commitment to service. Service shall be broadly defined and may include, but not be limited to, work with youth, seniors, handicapped, the needy, support for global ini-

tiatives, or humanitarian service through governments or other agencies. Lions are ineligible to be considered for this award.

How will he/she be selected?

All Lions clubs within District C-1 shall be encouraged to submit a resume of a deserving individual to the selection committee. (Clubs may wish to conduct a local program within agencies may submit resumes for those they consider deserving of this prestigious recognition.

Submissions from Lions clubs, in- gdividuals, and agencies may be made in memory of

someone who is deceased. The second deadline for submissions to be re-up ceived is September 15.

Submissions shall be valid only for the year in which they have been submitted.

Selection Committee

The committee shall be made up of: District C-1 Immediate Past Discontrict Governor (chair),

District C-1 District Governor, a Past International Director, and the District C-1 Awards Chairperson.

What is the recognition?

Public recognition of the individual and their cause will be emphasized. A biography will be provided and the recipient will be named a Melvin Jones Fellow. Every effort should be made to have press/TV coverage. If that should not be practical, the District C-1 Public Relations chairperson shall ensure that news outlets are notified.

Funding requirements

Funds to purchase a Melvin Jones Fellowship to come from District C-1 and will be a budgeted item.

Where and When?

The presentation will be made annually at the District C-1 Convention.

Multiple District C Hall of Fame

is a Multiple District award, The nominations must be sent to the District for a vote at the Case district convention.

Any Lion, Lioness, Lions Club, Lioness of Club, or Zone may nominate a of candidate from District C-I to the Multiple District C Hall of Fame.

- 1. There is no nomination fee.
- 2. There may be a maximum of one (I) candidate per district, inducted into the Hall of Farne each year.
- The Awards Chairman must receive nominations at least 30 days prior to the District's Annual Convention. Each individual District will hold an election to determine the successful

- candidate.
- The award may be presented to either a Lion or Lioness and only one recipient per District may be elected annually.
- 5. The award may be presented posthumously.
- Each candidate must have 15 years of service and be two years removed from Council (if they have served as a member of the Council of Governors).
- 7. Each candidate should have qualifications above and beyond the call of duty including social and human endeavours. He/she should be of good moral character and have a good reputation in his/her community.
- . All sponsors will use the standard form, No other will be accepted.
- The sponsors will ensure the candidate, or representative, will be in attendance at the Multiple District Convention.
- 10. All successful candidates will be inducted to the Hall of Fame at the next MD C convention.
- 11. A brief biography of each inductee shall be announced to the delegates attending the annual MD C convention, and published in the subsequent MD C newsletter.

The 2004 Indian Ocean earthquake occurred at 00:58:53 UTC on 26 December. The shock had a magnitude of 9.1–9.3, triggering a series of devastating tsunamis along the coasts of most landmasses bordering the Indian Ocean, killing 230,000–280,000 people. It was one of the deadliest natural disasters in recorded history. Indonesia was the hardest-hit country, followed by Sri Lanka.
